Note 1:

Public Holidays on account of Sree Panchami (January 28th) and the Traditional Court holiday on account of the second day of Sree Panchami (January 29th) fall on Fourth Saturday & Sunday respectively, Public holiday on account of Bengali New Year's Day (April 14th) falls on Second Saturday.

Holiday on account of New Year's Day (January 1st), Public Holidays on account of Fateha-Duaz-Daham (February 5th), Muharram (November 25th) and Sectional Holiday

on account of Buddha Purnima (May 6th) fall on Sundays.

Note 2:

If any of the Muslim Festivals notified above does not fall on the day notified, Muslim officials and employees of the Civil Court's in West Bengal may be granted a holiday on the day on which the festival is actually observed in addition to the holiday on the day notified.

Note 3:

Sectional holiday on account of Mahabir Jayanti (April 4th) may also be granted, when possible, to the Jain employees. Sectional holiday on account of Baisakhi (April 13th) coincides with the Traditional Civil Court holiday on account of Chaitra Sankranti. In West Bengal, all Officials, Suitors and Witnesses who profess the Brahmo faith may be granted, when possible, 3 (three) days' holidays on account of Maghotsav one day before and one day after that date.

Note 4:

The Chief Judge, City Civil Court, Calcutta may be empowered to declare local holidays not exceeding 2 days in a year according to the prevalent customs in consultation with the local Bar Association.

Note 5:

All 2nd and 4th Saturdays of the months have been declared as holidays for the Subordinate Civil Courts in West Bengal Vide F.C. Resulution dated 06.08.92.
