Until separate staff are provided to the establishment of Legal Services Authority the Court Staff who are deputed to attend Lok Adalat work shall be paid Compensatory Allowance @ 5% of their basic pay if they are deputed during general holidays may be granted Compensatory leave for the holidays foregone.
